**CLINIC INFORMATION:** Trainer Mary Rose Anderson competes in a variety of obstacle course events. She has been competing in EXCA since 2011 and recently won the 2018 Championship at the Western States Horse Expo in Pomona. In training a horse, she finds that the methods to use are “those that are first built on a solid foundation. The start to approaching obstacles and having your methods work in your favor are developed in doing ground work and then piecing together those foundation exercises you’ve reinforced under saddle. This builds confidence and leadership each horse is seeking in their rider no matter what’s being asked of them.”
